



## 1. HANDICRAFTS AND CARPET SECTOR

#### 1.1 Sector Overview

Handicrafts and Carpet is an export-oriented sector where approximately 60-65% of the products manufactured by handicrafts sector and 90% by the carpet sector are exported. In the year 2020-21 and 2021-22 India exported Handicrafts of about 25679.98 Crores and 33253.00 Crores respectively. Similarly exports of handmade carpets and other floor coverings in year 2020-21 and 2021-22(P) were 13810.41 crores and 16640.26 Crores respectively. Handicrafts sector employs around 7.3 million people mostly from rural and semi urban areas where as Carpet sector employs approx. 2 million weavers.

"Item or product produced through manual skills, with or without mechanical or electrical or other processes, which appeals to the eye, due to the characteristics of being artistic or aesthetic or creative or ethnic or being representative of cultural or religious or social symbols or practices, whether traditional or contemporary. These items or products may or may not have a functional utility and can be used as decorative items or gifts".

The Handicrafts Sector plays a significant & important role in the country's economy. It provides employment to a vast segment of the craftsperson in rural & semi-urban areas and generates substantial foreign exchange for the country while preserving its cultural heritage. Moreover, handicrafts have great potential, as they hold the key for sustaining not only the existing set of millions of artisans spread over the length and breadth of the country but also for the increasingly large number of new entrants in the crafts activity. Presently, handicrafts contribute substantially to employment generation and exports.

#### THE HANDICRAFTS INDUSTRY

The Small Scale and Cottage Sector helps solve the artisans' social and economic problems by employing approx. 7.3 million artisans, including a large number of women and people belonging to weaker sections of society. In addition to the high potential for employment, the Sector is economically important from the point of low capital investment, high ratio of value addition, and a high potential for export and foreign exchange earnings for the country. The industry is highly labour intensive and decentralized, being spread all over the country in rural and urban areas. Many artisans are engaged in specific crafts work on a part-time basis.

India is one of the important suppliers of handicrafts to the world market. Although exports of Handicrafts appear to be sizable, India's share in world imports is tiny. Despite a large production base and having many artisans, India has not been able to encash existing opportunities.

Handicraft is a sector that is still explored from the point of view of hidden potential areas. Looking into the reason for the small share of Indian handicrafts in the world market, the main reason is inadequate 'SEARCH & EXPLORATION OF HIDDEN CRAFTS OF INDIA' that includes the many crafts which Indian Handicraft Industry has not ever touched.

In the changing world scenario, craft products exported to various countries largely constitute a part of lifestyle products in the international market. There is a significant demand impact due to the changing consumer taste and trends. Because of this, it is high time for the Indian Handicraft Industry to go into the details of changing designs, patterns, product development, innovations and requisite change in production facilities for a variety of materials, production techniques, and related expertise to achieve a leadership position in the fast-growing




competitiveness with other countries.

The 7.3 million craft persons are the backbone of the Indian Handicraft Industry. Their inherent skill, technique, and traditional craftsmanship are quite sufficient for the primary platform. However, in the changing world market, these craft persons need institutional support, i.e., craft pockets for value addition and an edge over competitors like China, Korea, Thailand, etc.

#### **EXPORT OF HANDICRAFTS**

Handicraft is a labour-intensive sector with a high potential for employment for the poorer section of society, especially in rural areas. Moreover, it is economically significant because of low capital investment, high-value addition, negligible import content, and a high potential for export earnings.



The emergence of the handicrafts sector, as one of the sources of foreign exchange earnings for the country, is evident from the data of exports of all India's handicrafts from India. Approx. 60 to 65% of the total produce of Handicrafts products is exported.

#### **CARPETS**

Indian Handmade Carpet Industry is Highly Labour Intensive and employs over 2.3 Lakhs workers/artisans especially women directly or indirectly in the rural areas. Most of the artisans/ weavers employed are from the weaker section of the society and this trade provides extra and alternate occupation to them, including farmers and others at their homes.

The art of carpet weaving is traditional knowledge and skill, representing the continuity of the age-old Indian heritage and the socio-cultural tradition of weaving communities and thus has given Indian carpets a renowned position in the world.



The magnificence of Indian carpet weaving and the intricate patterns that have emerged from it have substantially increased India's carpet exports and placed it prominently on the international carpet map and thus has made it the largest exporter of handmade carpets in the world. The handloom sector is one of the major sectors with a substantial contribution to the GDP, but at present is suffering from high competition from power looms due to the very nature of the handmade sector being unorganized and dispersed.

The carpet tradition in India needs to be safeguarded as the knowledge/ skill related to the craft is on the verge of losing its identity.


#### **CARPET INDUSTRY**

India is today a clear leader in the international handmade carpet market. India's heritage of handmade carpet has been recognized worldwide with a commending share in global exports for its subtle elegance, eco-friendliness and exquisite, vibrant colour craftsmanship with a human touch. India is exporting to more than 70 countries in the world, mainly to the USA, Germany, Canada, U.K., Australia, South Africa, France, Italy, Brazil, etc.

## 1.3 Geographical Indication (GI) Crafts of India

Geographical Indications (GIs): The Geographical Indications of Goods (Registration and Protection) Act 1999 (the Act) provide for registration of Handicrafts (& Handlooms) as Geographical indications (GI). Handicraft (& Handlooms) is covered under Section 2(f) of the Act which states that "goods" means any agricultural, natural or manufactured goods or any goods of Handicraft (& Handlooms) or of industry and includes food stuff. Handicraft artisans & weavers can be registered as Authorized Users for the registered Geographical Indications as provided under Section 7(3) read with Section 17 of the Act. The Act provides that any person claiming to be the producer of the goods in respect of which a geographical indication has been registered under section 6 may apply in writing to the Registrar in the prescribed manner for registering him as an authorized user of such geographical indication. As on July 31, 2016, 1152 GI Authorized user have been registered under the Act for handicraft (& Handloom) goods.

#### WHAT RIGHTS DOES A GEOGRAPHICAL INDICATION PROVIDE?

A geographical indication right enables those who have the right to use the indication to prevent its use by a third party whose product does not conform to the applicable standards. However, a protected geographical indication does not enable the holder to prevent someone from making a product using the same techniques as those set out in the standards for that indication. Protection for a geographical indication is usually obtained by acquiring a right over the sign that constitutes the indication.

# 2. HANDICRAFTS AND CARPET SECTOR SKILL COUNCIL

## 2.1 Introduction

Handicrafts and Carpet Sector Skill Council (HCSSC) which is recognized Awarding Body of National Council for Vocational Education and Training-NCVET and has been established in the year 2014 with a core objective to provide deployable resources to the Handicrafts and Carpet Sector by enabling competency-based training as per the standards set in consultation with the industry. HCSSC is jointly promoted by Export Promotion Council for Handicrafts (EPCH), Carpet Export Promotion Council (CEPC) and National Skill Development Corporation (NSDC) under the aegis of Ministry of Skills Development and Entrepreneurship (MSDE) and Ministry of Textiles, In-line Ministry, Government of India.

Currently the Council has already trained and certified approx. 3 Lakhs trainees across India in various skill development schemes such as Pradhan Mantri Kaushal Vikas Yojna (PMKVY)- Recognition of Prior Learning-RPL, Short Term Training-STT and Special Projects, State Skill Development Missions, Development Commissioner Handicrafts-DC(H), and National Urban Livelihood Mission-NULM. Our work spans across various sub-sectors of Handicrafts including Carpets, Ceramics, Fashion jewellery, Glassware, Woodware, Stonecraft, Metalware, Paper mache, Hand crafted textiles, Hand crocheted textiles, Handicrafts (agarbatti), Handicrafts (bamboo) etc. HCSSC has developed more than 100 Qualifications out of which 87 Qualifications are approved by National Skills Qualification Committee of National Council for Vocational Education and Training-NCVET.

#### 2.2 Mission, Vision and Objectives

#### **MISSION**

The HCSSC's mission involves the overall development of skills and standards related to the Handicrafts and Carpet sector. Since inception HCSSC aims at developing NOSs for over 129 job roles, certifying up to 2 million candidates, training as much as 5 thousand trainers and affiliating about 150 training institutes.

#### VISION

HCSSC envisions the development of the Handicrafts and Carpet sector. Its views incline to the skill development of every individual and group connected to the sector. HCSSC visualizes the Handicrafts and Carpet sector making its mark in the society – a society acknowledging the art, and also being employment-friendly for the trained artisans.

#### **OBJECTIVES**

- Creating skill development plan for the Handicrafts and Carpet sector
- Developing skill competency based on qualifications and standards
- Capacity building of young artisans to strengthen their skills and skill up gradation of existing artisans
- Developing Labor Market Information System (LMIS) for the Handicrafts and Carpet sector
- Improving training delivery and promotion of academies of excellence



# 2.3 Skilling Process

Training is one of the fundamental elements of the skill development process. The training conducted by HCSSC can be segregated into three different segments.

#### TRAINING OF TRAINEES

The first and foremost segment is the training of trainees- these are the candidates aspiring to be trained in specific skills. These trainings are carried out by the various Industry members and training partners affiliated to HCSSC.

There are different programs under different crafts on which aspiring candidates can pursue training on. HCSSC carries out various Skilling, Upskilling and Reskilling programs. In fresh training, candidates are trained from scratch in a given job role. On the other hand, in upskilling the candidates are meant to have prior knowledge on the job role and are trained on additional requirements such as quality aspects, design & innovations, marketing knowledge, digital literacy, financial literacy and Entrepreneurship Skills.

#### TRAINING OF TRAINERS (TOT)

The trainers responsible to train the trainees must be knowledgeable and be equipped with the skills to deliver training. They must be experts in their own subjects. The efficiency of the trainers would reflect the proficiency of the training they provide to the candidates in the specific skills. Therefore, HCSSC conducts training for trainers to train and guide the trainers to build their capacities to deliver training.

#### TRAINING OF MASTER TRAINER (TOMT)

A domain skills expert possessing minimum educational qualification along with relevant sectoral work experience and training experience is known as a Master Trainer. A certified Master Trainer is a pre-requisite for conducting any ToT/ ToA programs.

#### TRAINING OF ASSESSORS (TOA)

Assessment is an indispensable process in regards to the skill development process. It is only through an assessment that the quality of training and the trainees could be measured. Therefore, it is essential to assure the quality of assessment. For the purpose of providing a qualitative assessment, HCSSC conducts training for assessors at different times of the years. In these training the assessors are trained on the standards of assessment and its various criteria.

#### **ASSESSMENT**

Proper assessment of the trainees is one of the most important parts of the skill development process. The quality of assessment would define the standard of the trained trainees. For that matter, HCSSC has affiliated assessment agencies to conduct the assessments as per the standards set by NSDC and HCSSC. The assessment agencies have assessors who assess the trainees on the set standards. In order to guide and assist the assessors, HCSSC conducts Training of Assessors (TOA) (for more information check the Training of Assessors section of the Training tab).



#### **CERTIFICATION**

Certification is the final process of the skill development process. After the completion of training delivered by certified trainers at affiliated training centers, the trainees are assessed by certified assessors. These assessors evaluate the trainees on the basis of the various standards set by NSDC and HCSSC. On successfully completing the training and assessment, depending on the grades/marks obtained in the assessments, the trainees are certified. The certification process includes the grading of trainees with respect to the marks/grades earned in the evaluation procedure. Subsequently, the trainees are offered their certificates.

## 3. SCOPE OF WORK

# 3.1 List of approved Qualifications of HCSSC

### NOS (NATIONAL OCCUPATIONAL STANDARD)

NOS, or National Occupational Standard, specify the quality standard required by a distinct task that is being carried out in doing a job. For example, one of the NOSs for the Acid Cleaner (Metalware) job role is wash metal product with acid. NOSs define the quality and standard of performance, knowledge and understanding while carrying out a specific activity in the workplace. NOSs are the salient features that establish the quality requirements of a job role.

#### **QUALIFICATIONS**

Qualification is a set of NOSs that are associated to a specific job role. Every job role in different industry sectors has distinct qualification aligned to it. For all the job roles under the different crafts that fall under Handicrafts and Carpet Sector, there are specified Qualifications aligned to them.

# 3.2 Affiliates

HCSSC affiliates organizations for the proper delivery of services pertaining to skilling process. HCSSC basically offers two types of affiliation - affiliation as Industry members and training partners with training centers through Skill India Portal and affiliation as assessment agencies that are recognized by National Council for Vocational Education and Training. The organizations have to adhere to guidelines of NCVET to get affiliated with HCSSC.

#### 3.3 Affiliation Process

Abody or an organization is affiliated by HCSSC either as an Industry member, Training Partner or an Assessment Agencies. To be affiliated as a Training Partner, an organization must first be affiliated through the Skill India Portal. The second stage of the affiliation process includes filling the affiliation form provided by HCSSC. However, to be affiliated as an Assessment Agency for HCSSC, an assessment agency should be recognized by NCVET and subsequently respond to Request for Proposal (RFP) released by HCSSC from time to time on its website. After the completion of the affiliation process conducted by HCSSC, the details of the Assessment Agencies are updated on Skill India Portal by HCSSC.

## 3.4 Training Partners

Training partners are integral parts of HCSSC considering their role in the skilling process. The affiliated training partners carry out the training function for HCSSC. Their role is to train candidates as per the standards required for the various job roles. HCSSC has affiliated many training partners to meet the training requirements across the country.

HCSSC's affiliated training providers have implemented NOS based training programs on various Qualifications in the Handicrafts and Carpet Sector across the country. These trainings focus on developing hands on skills for the trainees, through theoretical and practical sessions.

SATURDAY, 18TH SEPTEMBER 2021



Hon'ble Minister of State, Ministry of Skill Development and Entrepreneurship, Shri. Rajeev Chandrasekhar visited the traditional and heritage crafts cluster of Dimapur, Nagaland at Sovima Village. He was accompanied by Shri, Mmhonlumo Kikon, advisor of IT&C, NRE, Science and Technology, and Shri. Imnatiba Jamir, advisor of Labour and Employment, Skill Development and Entrepreneurship and Industries and Commerce.



Ms. Jesmina Zeliang, Executive Member and CEO Mr. Krishan Kumar from Handicrafts and Carpet Sector Skill Council walked him through the Training Centre where more than 600 artisans and weavers have been trained through Industry based training program and have been employed by the Industry subsequently. The Centre has the facility of both training labs and exhibition hall. 





## INDEPENDENT AUDITOR'S REPORT

## Opinion

# SCHEDULES-1 HANDICRAFTS AND CARPET SECTOR SKILL COUNCIL SIGNIFICANT ACCOUNTING POLICIES & NOTES ON ACCOUNTS FOR THE YEAR ENDED ON 31ST MARCH 2022

## (i) About the Council

Handicrafts and Carpet Sector Skill Council (hereinafter referred to "the soceity") was incorporated in the State of New Delhi. The Trust is formed for the formation of standards (National Occupational Standards) for handicraft artisans and workers. It has been registered as General public utility trust or society u/s 12A of Income Tax Act, 1961.

## (ii) Significant Accounting Policies

The significant Accounting Policies followed by the soceity are as stated below:

### (a) Basis of Preparation

The Financial Statements have been prepared on the historical cost convention and on going concern assumption. These statements have been prepared in accordance with the generally accepted accounting principles and the applicable mandatory accounting standards. The preparation required adoption of estimates and assumptions that can affect the reported amounts of revenue and expenditure and the assets and liabilities as well as the disclosure of contingent liabilities. Difference between the actual results and estimates are recognised in the year in which they become known or materialize.

## (b) Revenue Recognition

Income from Subscription from Members, Grant-In-Aid from NSDC, Industries Contribution and Interest Income are recognized on accrual basis. Donations are recognized on receipt basis.

Assessment income is recognised on the basis of approval of the batches/ candidates under Skill India Portal (SIP) of NSDC and other government agencies.

Grant-in-Aid from NSDC and Other Ministries are being booked at the time of receipt of money or Utilisation Certificate submitted with the respective Departments.

## (c) Government Grants

i. Grants in the nature of revenue with specific conditions for utilization is recognized as income, to the extent actually spent during the financial year and amount not utilized is carried as current liability. Expenses incurred against sanctioned grants eligible as per prevailing Government policy; with reasonable certainty to be released, are shown as recoverable, where grants are yet to be disbursed.

- Excess or Short receipt of Grant against recoverable amount is recognized in the Income & Expenditure account in the year of its actual receipt.
- iii. Grants in the nature of capital are transferred to Capital Assets Fund to the extent of amount actually utilized and amount not utilized is carried as current liability.

## (d) Intangible Assets

The Intangible assets (Intellectual Property Rights) have been developed by utilizing government grant from national Skill Development Corporation for the purpose of National Occupational Standards (NOS). The same has been by way of government grant recognized at a nominal value or at the acquisition cost. The same has been recognized in the books as per Accounting Standard 26 as issued by The Institute of Chartered Accountants of India.

Intangible assets purchased are measured at cost or fair value as of the date of acquisition, as applicable, less accumulated amortization and accumulated impairment, if any. Intangible assets are amortized on a written down basis, from the date that are available for use. The estimated useful life of Intangible assets i.e. National Occupational Standards is 10 years.







Sector Skill Council (SSC) comprises well defined broad collection of skill domains of similar characteristics. Under SSC different sectors are identified with connected skills that are commonly required to do major activities in a set of organizations. Each sub-sector has significant Occupation Standards (OS). OS specifies the standards of performance than an individual must achieve when carrying out a function in the workplace. It includes the knowledge and understanding they need to meet the requirements of the standard consistently. Occupational Standards are applicable both in the Indian and global contexts. QP comprises a set of NOS (National Occupation Standards), together with the educational training and other criteria required to perform a job role. NOS are Occupational Standards which apply uniquely in the Indian context.

HCSSC has developed 129 Qualifications comprising more than 250 National Occupation Standards (NOSs) out of these 96 qualifications were NSQC Approved and out of these 96 Qualifications, 48 were rationalized subject to expiry of the existing Qualifications. After rationalization and merger of the Qualifications total 87 NSQC approved Qualifications are active (comprising 18 new NSQC approved Qualifications).

## (f) Fixed Assets

- (i) Depreciation on fixed assets is generally provided on Written down method at the rates and in the manner prescribed in the Income Tax Act, 1961 by charging the same to Income & Expenditure Account and crediting to Asset A/c. In the case of Intangible asset depreciation has been calculated on WDV basis.
- (ii) In respect of additions prior to 1st October, depreciation is provided for the full year and at half the rate for other additions & Fixed Assets are recorded at cost.

## (g) Employee Benefits

(i) All employee benefits payable (Agreed between Employer Company and its employees) within twelve months of rendering services are classified as short term employee benefits and recognized in the period in which the employee rendered the related services.

### (ii) Leave Encashment

The regular employee is entitled for 30 Earned Leaves in a calendar year. An employee can encash 50% of remaining earned leaves in a year and rest 50% will carry forward in the next subsequent calendar year. Earned Leaves can be accumulated up to 300 days. However, the person is leaving the council on resignation can encash the balance Earned Leaves. In case of termination balance Earned leaves will be lansed

## (III) Gratuity

- (i) The council is complying with statutory requirement of gratuity under the "Payment of Gratulty Act. 1972". Employee is eligible to receive gratuity as per law.
- (ii) The liability in respect of the defined benefit plan in the form of gratuity is recognised in the vear in which it is applicable on an employee (as per provision of Gratuity Act).

## (iv) Provident Fund

The council is complying with statutory requirement of Provident Fund under "Employees" Provident Fund Organisation, Minstry of Labour of Employment"

The PF will be applicable for permanent employees of the council only. PF Related to contractual labour is being deposited by the contractor only.

## (h) Investment

i) Investments, which are readily realizable and intended to be held for not more than one year from the date on which such investments are made, are classified as current investments. All other investments are classified as long term investments.

ii) Long term investments are carried at cost.



## (i) Provisions, Contingent Liabilities & Contingent Assets

a) A provision is recognized when the Council has present obligations as a result of past event, it is probable that an outflow of resources embodying economics benefits will be required to settle the obligations and reliable estimate can be made of amount of the obligation. Provisions are not discounted at their present value and are determined based on best estimate required to settle the obligation at reporting date. These estimates are reviewed at each reporting date and adjusted to reflect the current best estimates.

b) A Contingent liability is a possible obligation that arises from the past events whose existence will be confirmed by the occurrence of one or more uncertain future events beyond the control of the company or a present obligation that is not recognized because it is not probable that an outflow of resources will be required to settle the obligation. A contingent liability also arises in extremely rare cases where there is liability that cannot be recognized because it cannot be measured reliably. The Society does not recognize a contingent liability but discloses its existence in the financial statements.
